Foto 4: Es necesario continuar con el muro perimetral para cubrir la cuneta de drenaje y además, se debe fundir dicha cuneta.

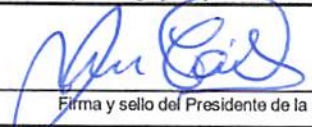
